Common Core and its testing regime were touted as “an absolute game-changer in public education,” yet the evidence so far suggests that kids are actually learning less under it. Why, then, was such a costly and disruptive agenda imposed on the nation’s schools? Who benefits? And how can citizens regain

The book concludes by discussing some utopian and dystopian future scenarios and asking whether the West can transcend its crisis of rationality.
