This book constitutes the refereed proceedings of the 21st International Conference on Industrial and Engineering Applications of Artificial Intelligence and Expert Systems, IEA/AIE 2008, held in Wroclaw, Poland, in June 2008. The 75 revised full papers presented were carefully reviewed and selected from 302 submissions. The papers are organized in topical sections on computer vision, fuzzy system applications, robot and manufacturing, data mining and KDS, neural networks, machine learning, natural language processing, internet application and education, heuristic search, application systems, agent-based system, evolutionary and genetic algorithms, knowledge management, and other applications. Welcome to the proceedings of the 2010 International Conferences on Database Theory and Application (DTA 2010), and Bio-Science and Bio-Technology (BSBT 2010) – two of the partnering events of the Second International Mega-Conference on Future Generation Information Technology (FGIT 2010). DTA and BSBT bring together researchers from academia and industry as well as practitioners to share ideas, problems and solutions relating to the multifaceted aspects of databases, data mining and biomedicine, including their links to computational sciences, mathematics and information technology. In total, 1,630 papers were submitted to FGIT 2010 from 30 countries, which includes 175 papers submitted to DTA/BSBT 2010. The submitted papers went through a rigorous reviewing process: 395 of the 1,630 papers were accepted for FGIT 2010, while 40 papers were accepted for DTA/BSBT 2010. Of the 40 papers 6 were selected for the special FGIT 2010 volume published by Springer in the LNCS series. 31 papers are published in this volume, and 3 papers were withdrawn due to technical reasons. The explosive growth of the Internet and the Web have created an ever-growing demand for information systems, and ever-growing challenges for Information Systems Engineering. The series of Conferences on Advanced Information Systems Engineering (CAiSE) was launched in Scandinavia by Janis Bubenko and Arne Solvberg in 1989, became an important European conference, and was held annually in major European sites throughout the 1990s. Now, in its 14th year, CAiSE was held for the first time outside Europe, showcasing international research on information systems and their engineering.
